a)Declaration of Interest

Councillor Gale declared an interest in item -Community Centre (heating problems)

b) N-Power Community Fund – Applications

Members agreed to recommend supporting the following:-

- i)Baring Court (day out/provision of entertainment for residents of the scheme) for £250 from the fund.
- ii)TLCA (start up cost of a new Junior football team in Tow law) for £250 from the fund
- iii)Tow Law 1st Scouts Group (Beavers) (fund the hire of transport to take the group to events etc) for £100 from the fund

Members agreed not to support the application from Anne Marie Mason (does not meet the criteria)

Members also agreed for the Clerk to write to Emma Scott regarding the outstanding application for Nell and Sadie Morris for contribution towards dancing costs.

c) CCTV system in Tow law

Members agreed for the Clerk/Assist Clerk to research for any funding opportunities to replace the present three camera system. It was suggested to complete an application form for the County

Durham Community Foundation and report to a future meeting of the Committee.

d) Community Centre – heating problems

Councillor Gale/The Clerk updated the meeting on recent problems with the central heating system throughout the building. The radiator in the Clerk's office (electric) is faulty and is awaiting repair (temporary heater provided by the Chair) other heating problems have been addressed and should now be operating correctly. Situation to be monitored and the Clerk to report to Chair/Vice Chair of any future problems.

e)Publication of individual names in the Public domain Members agreed to continue with the present practise of naming successful applicants for funding (N Power Community Fund) in the Council's minutes (transparently/accountability). Produce a Council Newsletter in May setting out the Criteria for applying for N-Power Community Funding so that all residents are aware of what funding is available and who can apply (Groups and individuals).

f) Christmas Trees 2013

Members proposed:-

i)Provide the Christmas Trees to houses in Tow Law (65 approx) ii)Continue to look for a suitable piece of land to use for the Civic tree (which was requested by the recent petition received by the Town

Council). It was suggested to look at the possibility of siteing a tree at the entrance to Deerness Estate

Members agreed to accept the recommendations of the Finance and General Purposes Committee and for the cheques to be raised as soon as possible for the three successful applicants from the N-Power Community Fund.
